## NOTIFICATION

### AMENDMENTS IN REGULATION NO. 18/2008

Regulation No. 18/2008 has come into effect from 01-01-2008. The said Regulation was subsequently amended vide Notification No. Regn/290 dated 20-06-2024. Further amendments have now been made in Regulation No. 18/2008 with effect from Admission Session 2026.

#### 11.3 INFRASTRUCTURE REQUIREMENT FOR DCA, PGDCA: SEATS PERMITTED EXISTING PROVISION

"In the first allotment, maximum 50 seats will be allotted in each Course. Thereafter, more seats can be allotted as per the norms provided in Point No. 11.5, 'Increase in the Number of Seats'."

#### AMENDED PROVISION

a). In the first allotment maximum 50 seats will be allotted in DCA course and maximum 50 seats will be allotted in PGDCA course.

b). Those Study Institutes who are associated for both DCA and PGDCA courses, will be allotted total 100 seats (both courses taken together) in the first allotment. These 100 seats can be utilized for either DCA course only or PGDCA course only or for both courses, based on actual admission.

c). More seats can be allotted, as per the norms provided in Point No. 11.5, 'Increase in the Number of Seats'."

#### 11.5 INCREASE IN THE NUMBER OF SEATS

##### EXISTING PROVISION

(xi) Seats in one course will not be interchanged/adjustable in another course.

##### AMENDED PROVISION

(xi) Except DCA and PGDCA courses Seats in one course will not be interchanged/adjustable in another course.


